



2017 STATE TRACK & FIELD QUALIFYING MEET APPLICATION PACKET

Before a meet can be approved as a State Qualifying Meet, the following checklist must be completed and verified:

- The meet must be entered by the host school on the school login page and request sanctioning from the AIA.
- A completed AIA Qualifying Track & Field Meet Application form (page 2) must be submitted to David Shapiro at the AIA. track@aiaonline.org
- Names of the Referee, Meet Director and Hy-tek Operator.

Once an approved qualifying meet is completed, the meet director must:

- 1- Forward a Hy-tek back-up file, to Sue Hysong chysong@cox.net within **72 hours** of completion of the meet.
- 2- Upload results to maxpreps.

Hy-Tek Track & Field Meet Manager is the software that is to be used for scoring and results of the qualifying meet.

- All approved State Qualifying Meets must use AIA determined school abbreviations found on the Track & Field page of AIA365.

CRITERIA FOR A STATE QUALIFYING TRACK & FIELD MEET

- AIA state qualifying track & field meets must be sanctioned and approved by the AIA for any state qualifying time, height or distance to be achieved.
- Five or more schools must participate in the meet.
- Three certified officials to include: Starter, Referee and Head Field Event Judge
- A fully automatic timing system and wind gauges are required for long and triple jump as well as the 100, 200 and high hurdles.
- Six Lane Umpires for the running events.
- **Wind readings must be on the hy-tek result files, that are sent to the MaxPreps, events with no wind readings will not count as qualifying marks for each heat and jumping event. It is recommended to include the entire series of jumps for back up.**
- State qualifying meet must follow the NFHS Rules Book.
- REFER to the AIA Coaches check list found on the AIA website under Coaches→Track.
