Location: Hidden Cove Golf Course, 1500 Golf Course Rd, Holbrook AZ

Race Times:

***Teams will need to check into the bullpen 15 minutes prior to the start of their race.**

Facilities: There will be porta potties available, but no locker room or showers.

Parking: Bus parking will be available at the golf course or at the Fuel Express Truck Stop located at 3747 Express Dr. Exit 283 off I-40 (the same exit the golf course is on). If you plan to park at the golf course: buses will need to park on the far east side of the parking lot. If your bus drivers do not want to watch the meet they should park at the truck stop to try to alleviate the congestion at the golf course.

Athletic Trainers: An athletic trainer will be onsite and will be located at the club house.

Awards: Medals will be awarded to the top fourteen (14) in each section. A Team Sectional Champion Plaque will also be awarded. Awards will be at the #1 tee box (next to the club house) immediately following the last race.

Course: The course is 3.1 miles on the golf course cart path. Start and finish line will be on grass on the #1 fairway. A copy of the map is attached.

Course walk through: 10:30am-12:45pm on Friday, November 8.

Rules: Rules are those of the current edition of the National Federation Track and Field/ Cross Country Rules and Records, AIA Constitution and Bylaws and these tournament instructions.

Meet Director: Paul Demuth- HHS Athletic Director

Entry Procedure: Each team must designate no more than seven runners. Entries are to be submitted online at www.athletic.net **Entry deadline is Wednesday October 30 before 12 pm.** Changes to your entries will be allowed at check in. IF you do NOT already have an athletic.net account you need to allow several days for your account to be set.

State Qualification: The top 50% of teams (5 or more runners) entered on athletic.net before the Nov 4 deadline from each section and any individual in the top twenty five (25) regardless of their teams position will advance to the state meet. If there is an odd number of teams competing, the number of qualifying teams will be rounded up. Thus, 15 scoring teams = 8 qualifiers.

Appeals All appeals must be processed through the Meet Referee. No appeals will be processed on judgment calls made by a meet official. The Meet Referee will be the final authority on rule infractions.

Bicycles Bicycles will not be allowed on the sectional courses. Coaches nor those associated with a team are to ride bicycles as it can create an unfair advantage. Bicycles will be used as by the Course Ushers.

Spikes Spikes ARE NOT allowed at Hidden Cove Golf Course.

Sectional BIB Instructions for Coaches

1. Inspect your team packet to ensure you received all your bibs
 - a. Immediately notify meet management if you are missing any
 - b. Very important – this must be done before leaving the packet pickup area
2. Distribute your bibs to all competing athletes
 - a. All athletes must wear their assigned bib, as assigned on your team roster
 - b. Athletes that are not registered should not use someone else's bib
 - c. Failure to properly distribute the bibs will result in inaccurate results
3. Athletes must properly secure their bibs with the provided safety pins
